## **Course Description & Purpose**

The purpose of the Intermediate Fetal Monitoring Course is to promote integration of knowledge and skills essential to clinical assessment, promotion, and evaluation of fetal well-being during labor. This two-day course focuses on the application of essential fetal monitoring knowledge and skills used in intrapartum nursing practice. The course consists of didactic and skill station sessions.

#### **Objectives**

At the conclusion of this course, participants will:

- Analyze fetal heart patterns, uterine activity, and their implications for fetal well-being
- Discuss indicated clinical interventions and related maternal-fetal physiology
- Effectively communicate verbal and written data about patient status
- Describe the roles and responsibilities of healthcare providers in the use of fetal heart monitoring in intrapartum care
- Demonstrate the psychomotor skills used in FHM

#### **Target Audience**

This course is designed for clinicians with a **minimum of 6 months** of perinatal experience using fetal heart monitoring in the intrapartum setting. It is NOT an introductory-level fetal monitoring course.

#### **Cancellation & Refund Policy**

If minimum enrollment is not met by the course registration deadline, the course may be canceled.
